3.03	EHFC	The following update was provided by EHFC and discussed with NEC International aid project Plans to support the Canadian Outreach Medical & Mission Team in 2019. This a 100% volunteer organization that charges no administration fees. They work closely with a few small very poor communities in Nicaragua and on the ground NGOs – they have been going to the same communities for 8 years and go twice a year In addition to many projects they also include well drilling, well repairs including maintenance of the systems, ecofriendly stoves, handwashing at local schools Are very interested in adding Public Health Inspectors to their team. They visit 2x per year for 10 days, Jan/Feb or Oct and fill a shipping container with medical and other much needed supplies. The trip usually costs \$1,600 per volunteer and includes air fare, meals and accommodation at a local orphanage. The cost is tax deductible. Once plans are finalized the EHFC will promote as part of our 30 th anniversary fund raising. Student conference sponsorship 10 students (6 CBU, 2 Conestoga, 2 Ryerson) 8 full registrations and 2 one-day registrations CBU financially supported 6 additional students – full registrations
