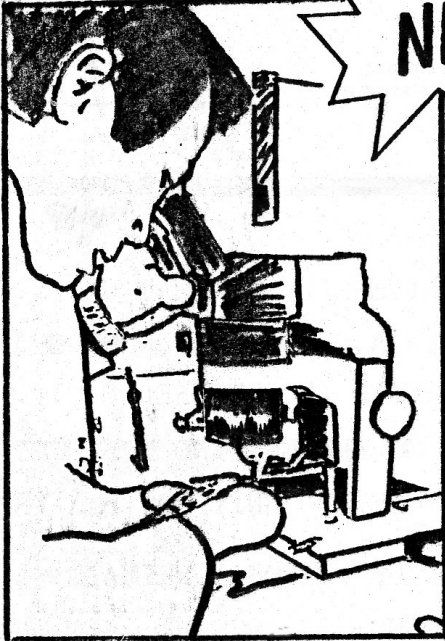

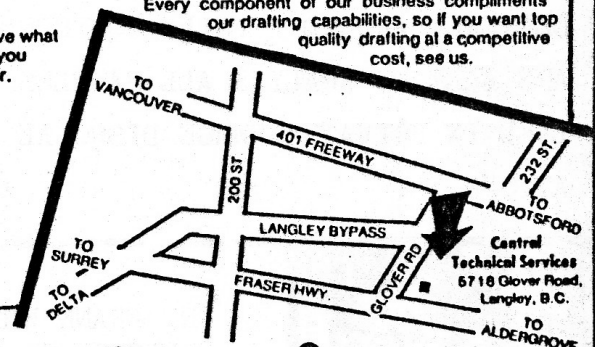

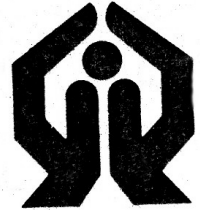


NEW APPOINTMENT

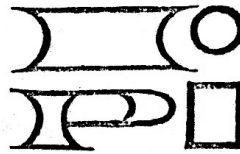

TO: ALL PUBLIC HEALTH INSPECTORS

In mid-February, we were pleased to announce the implementation of a new four-year degree program in Environmental Health. To keep you updated, we have gathered together some important follow-up notes.

Program Implementation: The program will be phased-in over a two year period, beginning September, 1980. In Fall, 1980, we will offer:

1. the 1st year of the degree program
2. the 3rd year of the degree program.

Admission Guidelines for Advanced Standing: Enrolment in the third year of the program will be limited to thirty-five (35) qualified applicants. Eligibility for advanced standing into the third year will be based on the following criteria:

1. Applicants must have acquired the C.P.H.I. (C) or the equivalent.
2. Preference will be given to applicants who achieved a "B" average in the certificate program(s).

Note: Applicants will be assessed on an individual basis. Applicants' employers may be contacted for a confidential assessment.

1980 Deadlines for Applications:

April 1, 1980: - deadline for submission of complete application - an application is complete when it includes current transcripts (obtain these by writing to the Institution attended - Registrar's Office).

Please note: photostat copies are acceptable only when they carry the official, signed seal of the Institution.

May 15, 1980: - deadline for the submission of \$60.00 deposit to reserve space in the program.

Along with the implementation of the degree program comes the phasing-out of the existing certificate programs. The Certificate in Public Health Inspection Program will be phased-out by offering the second year only (in Fall, 1980) to those currently enrolled in that program. The Health Administration Program, available by correspondence and evening study, is also being terminated. Students who are currently enrolled will have the opportunity to complete the program.

The degree program will be available on a full-time study basis through Day School and through Continuing Education at Ryerson. Discussion is currently under way with the Continuing Education Division to develop short-term, intensive credit courses for those who wish to obtain the degree but who are not able to study on a full-time basis.

SUNLAMPS AND SAFETY: A BURNING ISSUE

WHAT IS BEING DONE?

The Department of National Health and Welfare considers the potential health hazards from sunlamp exposure serious enough to propose regulations for sunlamps under the Radiation Emitting Devices Act.

These regulations require manufacturers to ensure that:

- The proportion of the more dangerous, shorter wavelength radiation emitted by the sunlamp is kept to a minimum.

- The sunlamp is equipped with a timer that will shut off the lamp automatically after a preset time interval.
- The sunlamp is designed so that it cannot be inserted into lamp sockets ordinarily used for domestic lighting.
- Goggles or other protective eyewear are supplied with the sunlamp.
- The sunlamp is clearly marked with a warning that its use can lead to burns and other types of injuries.
- Instructions for safe use accompany the sunlamp.

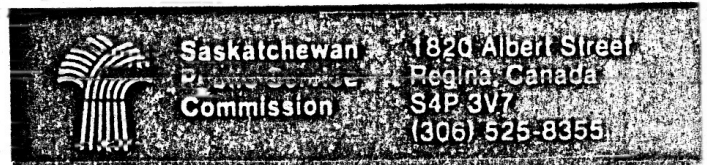
Public Health Inspectors
