GOVERNANCE REPORTS





Section 1: National Executive Council Report to Membership

Introduction:

The National Executive Council (NEC) is currently comprised of the elected Presidents of each CIPHI Branch, a National President, National President-Elect, and three National Directors (Policy & Governance, Education, and Advocacy). As of January 1, 2024, the one-year term of National Past-President Kevin Kapell was completed, and CIPHI thanks Kevin for his commitment to the organization throughout his five years as an Officer. Kevin will remain as the CIPHI representative on the National Collaborating Centre for Environmental Health (NCCEH) Board as well remaining the CIPHI liaison to the Environmental Health Foundation of Canada, until those terms expire in 2025.

The NEC is responsible for the day-to-day operations of CIPHI as set forth in the Canadian Not-for-Profit Corporation Act and the CIPHI Bylaws, enacted pursuant to the Act. The NEC is responsible for identifying and pursuing initiatives that support the objectives of CIPHI. All CIPHI Boards and Committees named within the Bylaws, including the Board of Certification, Council of Professional Experience, and Retirees Advocacy Committee report to the NEC.

CIPHI continues to exist due to the efforts of volunteers at both the National and Branch levels. We are honoured to receive, and appreciate the services of, National Webmaster Mike LeBlanc; Environmental Health Review Editor Wendy Pons; National Historian Tim Roark; Listserv Manager Peter Heywood; and Social Media Manager Vanessa Nickelo.

The business of the NEC is conducted via regularly scheduled monthly meetings, held virtually using the Google Meet platform. CIPHI utilizes additional software tools from Google for communications, document sharing and development, and collaborative practice, which are made freely available to the organization as a registered not-for-profit corporation. The NEC meets twice annually in-person in addition to these virtual monthly meetings, with the first of these in-person meetings occurring in Calgary, Alberta in January 2024 and the second to be held in Regina, Saskatchewan in September 2024. The CIPHI Annual Educational Conference will be held September 22 to September 25, 2024, in Regina, Saskatchewan.

The CIPHI President and President-Elect continue to meet monthly with the Chair and Vice Chair of the Board of Certification, the Chair and Audit Lead of the Council of Professional Experience and hold quarterly meetings with the President of the Environmental Health Foundation of Canada. Through work in collaboration with the Retirees Advocacy Committee, the NEC has finalized terms of reference and established quarterly meetings with this group, to advise, promote, and support retired environmental public health professionals.





CIPHI contracts administrative supports to the CIPHI Office, managed by MPS Executive Suites based in Vancouver, B.C. The staff assigned to the CIPHI portfolio have a deep understanding of our work and are committed to working collaboratively with the NEC and other CIPHI Committees to meet our operational needs. The NEC continues to identify ways to maximize the efficient use of these contracted services.

This report highlights the work conducted by CIPHI since the 2023 Annual General Meeting. Further details on large organizational initiatives are included in specific reports within this document.

Advocacy:

The CIPHI advocacy initiatives, led by National Advocacy Director Meaghen Allen, are focused on providing external-facing messaging to employers, the media, and members of the public about the role and function of environmental public health professionals in Canada. The 2024 advocacy campaign is specifically focused on targeting young adults to attract new candidates into the profession. Launched on July 31, 2024, and running for six weeks, the campaign highlights the unique nature of the role of environmental public health professionals using the tagline "a career outside of the ordinary". Advertisements were purchased on social media platforms as a means to raise awareness of environmental public health as an exciting and rewarding career path.

CIPHI's 2023 advocacy campaign built on the success of the 2022 "Made Possible By …" campaign to increase awareness of the field of environmental public health and highlight the complex work done by CIPHI members. Launched on August 22, 2023, the national campaign showed the breadth of facilities and services that CIPHI members interact with, and as with past campaigns utilized click through traffic to the CIPHI.ca website from digital advertisements as key performance indicators. During the six-week duration of the 2022 campaign, CIPHI saw nearly seven million impressions from our advertisements and nearly nine thousand visits to our website from those ads. For the 2023 Environmental Public Health Week, CIPHI highlighted member-submitted content outlining how members "support the health of all Canadians by …". We thank all CIPHI members who participated in the initiative and shared the unique and valuable work they do.

Education:

Under the leadership of National Education Director Kari Engele-Carter, CIPHI continues to provide educational offerings to environmental public health professionals through both virtual (webinar) options and the in-person Annual Education Conference. As in 2023, CIPHI has focused on providing educational sessions that supplement, and don't replace, those which are provided by our partner organizations including NCCEH, Ontario Public Health, and others. Offerings in 2024 on leadership, conflict resolution, and personal wellness have reflected feedback from our membership on what would be most valuable to them, which are also reflected in the updated professional development model for the organization.

CIPHI will continue to offer these educational sessions to both members and non-member environmental public health professionals and look forward to continued input from our membership on the types of sessions that would be useful.

Policy and Governance:

CIPHI National Policy & Governance Director Ann Thomas has worked closely with our legal counsel in 2024 to both update our operating approaches to ensure compliance with all relevant statutes and laws, as well as to update our National Bylaws. It was recognized that our current bylaws contained sections that were not in compliance with the current national Not-For-Profit Corporations Act. Further, CIPHI's relationships with external organizations including CIPHI Branches who are registered entities within their own provinces and the Environmental Health Foundation of Canada were neither formalized nor appropriate within the context of the Act. A complete rewrite of the National Bylaws has been approved by the NEC and will be brought to membership at the 2024 Annual General Meeting for ratification. The NEC is pleased that these updates provide better clarity on the role and function of the organization, and more importantly ensure compliance with federal legislation.

National and International Relationships

CIPHI continued to build upon its participation in national work related to public health, with CIPHI BOC Chair Gary Tam participating on behalf of the organization in the updates to the Public Health Agency of Canada's Core Competencies. Having a CIPHI perspective in this work ensures that our certification and professional development programs, as well as CIPHI's instructional objectives, are aligned throughout the spectrum of an environmental public health professional's career. Additionally, CIPHI maintains a position on the NCCEH Advisory Board to effectively link the knowledge translation needs of CIPHI members to the outputs of the NCCEH. In 2024, the CIPHI President met with executive leadership of employers in Saskatchewan and British Columbia to highlight the importance of the profession and to identify opportunities for collaboration on recruitment, retention, and recognition of environmental public health professionals. The NEC looks forward to additional opportunities for collaboration at national, provincial/territorial, and local levels to advance the interests of the profession.

On the international stage, CIPHI has continued to play a more prominent role as a member organization of the International Federation of Environmental Health (IFEH), with President-Elect Natalie Lowdon attending the IFEH National Congress in Perth, Australia. The NEC has formalized a terms of reference document outlining the leadership role of CIPHI Officers in these international spaces and looks forward to continuing our partnership with the IFEH Americas Group, including member organizations such as The National Environmental Health Association (NEHA), Jamaican Association of Public Health Inspectors (JAPHI), and Haitian Institute of Health and Environment (HIHE).

CIPHI has also moved to formalize our working relationship and partnership with NEHA through a Memorandum of Understanding, which highlights the reciprocal agreement for Officers from each organization to attend Annual Education Conferences. In 2024, the CIPHI National President and National President-Elect attended the NEHA AEC in Pittsburgh, Pennsylvania to continue the collaboration between the organizations and look forward to welcoming the NEHA President and other representatives to the CIPHI AEC in Regina, Saskatchewan. Recognizing the international nature of many emerging and climate-driven environmental public health concerns, CIPHI will continue to build these partnerships to advocate for the field and support the professional development of our members.





ICISP et Traduction

Continuing the work that was started in 2023, CIPHI continued the process of translating all appropriate operational documents into both official languages, including National Operating Policies and the professional development model. Additionally, just-in-time translation services ensure that BOC candidates can take their certification exams in either official language. For 2024, the introduction of an official ICISP website at ICISP.ca allows our French-speaking members to have equal and equitable access to organizational information.

Future Focus

The introduction of new CIPHI national bylaws sets a foundation for the organization to move into 2025 and beyond. While 2025 also marks the end of CIPHI's five-year strategy, focusing on the three pillars of advocacy, education, and policy and governance, the NEC anticipates these pillars will continue to the organizational focus. We thank the dedicated volunteers and CIPHI members who commit their time and energy to advancing the profession and protecting the health of all Canadians.

FINANCIAL SUMMARY


The financial status of the organization was overseen in 2023 by the National Executive Council lead by the CIPHI President.



First, an agenda item to create a new "Charlie Young Memorial Award" for 2025 was presented by the Retirees Advisory Committee to the National Executive Council. Every Year the following National Awards are offered to CIPHI members and eligible individuals.

Alex Cross Award

Awarded to a member for displaying the highest standards of professional practice during the past year.

Alexander Officer Award

Awarded to an organization or agency for outstanding and meritorious achievements in the field of public or environmental health.

Environmental Health Review Award

Awarded to a member, non-member, individual or organization for excellence in presenting an environmental health issue or topic to the public.

President's Award

Awarded to a former member of the NEC, BOC, CoPE, or EHFC who has demonstrated outstanding service and commitment to Canadian Institute of Public Health Inspectors while in office.





Honorary Membership

Awarded to a person who is not eligible for Regular, Retired or Life membership in CIPHI, for outstanding support, contribution or service to the association or Public Health Inspectors in Canada in general.

Life Membership

Awarded to a member of the CIPHI for outstanding service to the Institute, to his or her profession and/or to his or her community over an extended period of time.

Last year in 2023 there were again only two National awards presented at the conference in St. Johns, New Brunswick.

Narrative of Janice Gammie for CIPHI President's Award 2023

Keara, Lal, and Heidi enthusiastically nominate Janice Gammie for the 2023 CIPHI President's Award for her outstanding service and commitment to the Canadian Institute of Public Health Inspectors while she was in her positions with the Board of Certification and the National Exam Panel.

Janice certified with CIPHI in 1990 and has been active within the Institute over the course of her career.

Janice first joined the Board of Certification (BOC) in 2016 when she was appointed as the Nova Scotia / PEI branch representative. During her time on the BOC, she actively participated in school accreditation reviews; contributed to the development and implementation of the 2018 BOC Instructional Objectives; contributed to the development and implementation of the international candidate's equivalency exam; and, held the position of Chair for the National Exam Panel (NEP) from 2018 until the end of 2021. The BOC and NEP projects Janice worked on were no small tasks. Here is a more detailed list of her contributions to CIPHI while she was in office:

- She actively participated on multiple BOC school review panels: First Nations University of Canada (FNUC) review panel in June 2017, Concordia review panel in October 2017, Conestoga review panel (lead) in October 2018, FNUC review panel in May 2019.




Figure 2.1: Exam Pass Rates, October 2003 – April 2024

Regulations & Policy Updates

• The BOC has been working on the modernization of the BOC Regulations to reflect the current practices of the Board. The proposed BOC Regulations are currently under review by the National Executive Council.

Portfolios

- Terms of Reference of all BOC portfolios are updated.
- A new portfolio, BOC Education & Advocacy, was created to improve the communication of the current BOC information with specific target audience, including students, schools, training agencies, and examiners.

Reformatting BOC Written Segment Project

- The project team has been working on fine-tuning the new marking rubric to improve inter-rater reliability that can yield consistent marks between examiners. Once this phase is complete, the project team will engage with stakeholders to introduce the reformatted written segment process and the new marking rubric.
- The new process is planned to be implemented in the April 2026 exam.

CoPE provides leadership, vision, and the framework for the CPC program. It effectively communicates essential aspects of the CPC program and offers support to members with inquiries related to their professional development requirements. Additionally, CoPE is responsible for fostering accountability among Environmental Public Health Professionals nationwide by conducting audits of members' professional development entries.

CoPE Membership

CoPE has 12 members, who have been appointed through consultation with CIPHI Branches and the National Executive Council (NEC).

CoPE recruited both a Manitoba Branch Representative and a Saskatchewan Representative. It is of utmost importance that each province has representatives to assist with the audits.

Professional Development Model

Last year our team completed a review of professional development hours (PDHs) within the participation category submission for 2022. We identified confusion regarding the use of the subcategories Formal Mentoring and Job Shadowing. As well we have identified mental health and wellbeing as an important component of the practice of environmental public health.

We are pleased to announce that this has been incorporated into our professional development model for 2023. This went live when the MSC reopened for PD entries this past February.

New Member Service Centre

As with any new platform, the CIPHI office and CoPE have encountered several technical issues associated with the MSC in 2022, 2023 & 2024, and we have been diligently working with our vendor and the CIPHI office to address them. Unfortunately, these technical challenges have led to some members experiencing difficulties with entering their PDHs.





We continued to work with the vendor and are very pleased to announce that the 2023 audits are complete. CoPE has spent many hours to achieve this, and I would like to acknowledge all of the hard work from the team. This would not be possible without the quick responses and last-minute meetings.

Audit Results

As previously noted, the technical issues with the MSC yielded no audit result data for the 2022 entry year. However, CoPE worked to resolve these issues promptly, and we are encouraged to provide results for the 2023 professional development entries.

CoPE conducted audits of 69 regular members, of which 43 members failed their audit in the previous audit, and 26 members were randomly selected. Out of this, 668 individual entries were audited. In some cases, our team looked at the entries 2 or 3 times for verification purposes. Of the members audited we are happy to report that the pass rate has increased dramatically, when comparing the data in previous years.

In 2023, 1205 of 1759 regular certified members submitted at least 1 PDH, which means 69% of regular members participated. As a comparison, 60% of regular members participated in the CPC Program in 2020. Participation would include submitting PDHs equal to or greater than the required number of PDHs (30). We are striving to have the Technical Review of audits in place and completed in early fall 2024.

CoPE has been striving over the past few years to have more participation in the CPC program. It appears that the efforts are not in vain, the numbers indicate that the introduction of the new model and implementation of the new MSC has increased participation and compliance.

Section 4: Environmental Health Foundation of Canada Report to Membership

Introduction:

The Environmental Health Foundation of Canada (EHFC) is the Charitable Division of the Canadian Institute of Public Health Inspectors (CIPHI). The EHFC was founded in 1989 by motion of the CIPHI membership at their annual general meeting. The EHFC is a "working board" made up of volunteer trustees who support environmental public health education and research through collaboration, connection, and recognition with internal and external partners. The board has a hands-on role with the administrative functions of the organization such as financial management, strategic planning, social media, and fundraising. The EHFC Honorary Chair is Dr. David Jones who served as the first Chief Public Health Officer of Canada from 2004 to 2013.

Vision:

Advancing environmental public health education and research through collaboration connection, and recognition with internal and external partners.

Mission:

As the independent Charitable Division of the Canadian Institute of Public Health Inspectors we operate to support environmental public health protection in Canada and internationally through the development of educational materials, research, and aid projects with partner organizations.

Programs & Projects:

- Support environmental public health research.
- Develop and distribute environmental public health materials and educational products.
- Acknowledge the outstanding work of CIPHI members through prestigious awards.
- Sponsor environmental public health professional development.
- Partner to support domestic and international aid projects.
- Carry out fundraising activities.

The activities of the EHFC are coordinated by a Board of Trustees who come from the environmental public health profession, educational institutions, government, and industry. The ten-member, volunteer Board of Trustees dedicated numerous hours of their time in the past year to further the work of CIPHI's charitable division through three committees:

Executive Committee: consisting of the Chair, Vice Chair, Treasurer, Secretary, and Past Chair.

Advancement Committee: purpose is to assist the Board in fulfilling its responsibilities relating to funding and external awareness, including providing advice on fundraising, securing individual and corporate donors, communications, and marketing.

Governance Committee: purpose is to ensure that the board fulfills its legal, ethical, and functional responsibilities through adequate governance policy development; Trustee recruitment strategies, training programs; monitoring of board activities; and evaluation of board members performance.



In December 2023, the Board bid farewell to Fatih Sekercioglu. Fatih brought a wealth of experience to the Board with a background in Chemical Engineering, and a graduate of Ryerson University (BASc Public Health), University of Guelph (MSc Food Sciences), Willford Laurier University (MBA), and Western University (Doctor of Philosophy), 15 years as a

Public Health Manager, and as a current Associate Professor TMU. Fatih was a valued member of the Board who was a member of the Advancement Committee who championed the creation of the Nelson Fok Research Grant.







Recruitment:

There are currently six vacancies on the Board of Trustees. The EHFC Regulation allows for up to and including 15 board members. CIPHI members can earn professional development hours for volunteer service on the Board of CIPHI's Charitable Division.

Board Activities:

Since the last CIPHI AGM the Board hosted virtual meetings on December 3, 2022 (EHFC AGM), February 25, 2024, May 23, 2024, and upcoming meetings are planned for July 7, 2024, and September 8, 2024. The 2024 EHFC annual general meeting is planned for Sunday, December 1st. An AGM notice will be issued via the CIPHI Listserv, on the EHFC website (<u>https://www.ehfc.ca/</u>), and the EHFC social media accounts. The Board encourages CIPHI Members to participate to learn more about the work of CIPHI's Charitable Division.

Highlights of 2023/2024 Board work include:

- Creation of the Nelson Fok Research Grant in the annual amount of \$1,500 beginning in 2024.
- Established a partnership with Indigenous Services Canada in the creation of a four-year bursary program to provide financial support to Indigenous students pursing an education in the field of Environmental Public Health at a program accredited by CIPHI.
- Continued to work on updating Board Policy and Procedures.
- Sponsored the CIPHI National & NB/QC Branch AEC, CIPHI AB and MB Branch AEC with delegate lanyards, webcam covers, bookmark, door prizes, and nutrition break funding.
- Black History Month nominations project.
- All the EHFC forms including award/bursary applications/nominations and donations have all been converted into online fillable forms using the Jotform software application.
- The award nominations have been expanded to include retirees who are still active in EPH work.

Future Board Initiatives:

- Promotion and recognition of septic maintenance programs across Canada and advocating with partners in the creation of a National Septic Smart Day.
- Development of food safety education materials to be used by like-minded charity partners carrying out NGO work in poor countries where Spanish is the first language.





Financials:

The annual financial report for the period January 1, 2023, to December 31, 2023, has been submitted to the Charities Directorate of Revenue Canada for review and approval. The financial resources of the Foundation on **December 31, 2023**, including investments totaled **\$183,649.23** which represents a **\$70.51 increase** in EHFC assets compared to the 2022 year-end. The EHFC investments are endowed/entrusted funds from donors over the years for various awards and projects and can only be used as per the instructions of the donor.





Aid Projects:



In 2023 the EHFC Board of Trustees raised \$3,000 for the Stratford Rotary Club Aquabox Project through the generosity of our individual donors and a \$1,000 donation from the CIPHI Ontario Branch. Disasters such hurricanes, earthquakes, tsunamis, floods & fire seem to be increasing in frequency and severity around the world. They leave behind damaged infrastructure and contaminated water supplies. People resort to drinking any water they can find, usually from polluted sources. Those who drink this unsafe water are at increased risk from water-borne diseases such as cholera and typhoid. The elderly and very young are particularly vulnerable.

The EHFC Board of Trustees have chosen to partner again with the Rotary Club of Stratford (ON) in the production and distribution of AQUABOX which is a simple, low-cost filtration system that can provide purified drinking water to a family of five for up to a year. It uses silver-impregnated ceramic cartridges capable of filtering 15 litres of polluted water in each fill, trapping virtually 100% of harmful bacteria and protozoan cysts.

The AQUABOX is made from locally sourced components, and is assembled here in Stratford by dedicated volunteers, so there are NO administration costs. A basic hygiene kit is also packed in each unit. Global Medic, a non-profit disaster response organization of paramedics and first responder volunteers, distributes the AQUABOX units globally to those most in need, including disaster-stricken areas of Latin America, the Caribbean, and Southeast Asia.

The CIPHI ON Branch donated \$1,000 towards this project on behalf of its members. On May 2, 2024, Ralph Stanley, EHFC Vice-Chair and Pamela Scharfe, Past President presented a cheque for \$3,000 at the Stratford Rotary Club Spring lunch meetings. They also participated in the Stratford Rotary Club Aquabox assembly of 504 Aquaboxes put together in two hours by 40 local volunteers. The cost of each box is \$30 to produce so the \$3,000 donation resulted in the production of 100 of the 504 boxes through the generosity of our donors. Department of Pediatrics, University of Alberta is recognized as a collaborating centre by the WHO. It is a unique program addressing the impacts on children's health from environmental exposures (chemical, biological, physical, and social). The program considers all environmental factors to assess exposures, by integrating clinical, research and educational components.

The clinic has partnered with the EHFC Board to conduct an indoor air pollution survey project, the first of its kind in Canada, and thanks to your 2023 individual donations and a \$1,000 donation from CIPHI National and the NB/QC Branch AEC Committee and \$1,350 Starbucks Foundation Neighbourhood Grant made it possible to raise the \$5,000 needed for the study.

Indoor air pollution has a critical influence on human health, however considerable knowledge gaps remain. Our unique and timely interdisciplinary collaboration will generate multifaceted data describing opportunities to provide feasible options to improve population health through simple strategies including identifying products and activities that impact air quality and builds future opportunities in this highly under-represented area of research.





This interdisciplinary collaborative pilot project proposes a descriptive analysis aligning detailed home information, including appliances, household characteristics, activities, and product use with high sensitivity chemical analyses of air samples taken from each home. There is an opportunity for Concordia students/practicum students to be involved in the project.

On May 1, 2024, EHFC Chair Lena Parker and Board Trustee Jamie Carbert presented Dr. Anne Hicks, MD MSc PhD FRCPC, the ChEHC Director & Clinical Lead a \$5,000 donation to fund the project. For more details go to www.EHFC.ca/fundraising-initiatives.

TempSafe Products:



The EHFC have for sale the TempSafe[®] educational food safety materials which are available in magnets, clings, stickers, lapel buttons and large display formats. There is an option to include health agency information at the top of the product chosen for a nominal fee. The products are currently available in English, French and Spanish. The Board continues to offer large discounts for orders of 1,500 or more which allows for health agencies to combine orders to take advantage of the savings.

A sample of the product can be mailed to interested agencies. The EHFC receives a small percentage of all sales from the current printer as a source of unrestricted revenue to cover administration costs.

Fundraising:

The Board's 2023 fundraising goal was set at \$10,000. The funds raised were entrusted and used to financially support future annual environmental public health aid project(s) in Canada and/or internationally, and for a bursary to financially support students to attend the CIPHI national annual education conference. As of December 31, 2023, the Board exceeded its goal by raising \$10,644.

2023 AEC Final Report

CIPHI National Annual Education Conference 2023 was held downtown in Saint John, NB September 17th to 20th. 138 delegates attended in person from across Canada as well as 68 virtually through our event platform. The event was supported by eight sponsoring companies that also exhibited and an additional eight exhibiting companies. Notable speakers through the 2 ½ days of sessions included Chef Alain Bossé known as the "The Kilted Chef" with Peter Chapman of SKU Food, Atlantic First Nations Water Authority representatives, Storyteller Dave Smith, local historian Peter Ferguson and Matt Myers superintendent for the New Brunswick department of Justice and Public Safety. Aside from these notable speakers, additional speakers presented in three concurrent streams of sessions covering a wide range of environmental public health topics in lecture, workshop, and panel formats.

Environmental Health Review Report 2023-2024

Canadian Institute of Public Health Inspectors Annual General Meeting

A Summary of Activities (2024: V67 Issue 1 & 2)

- The new Editor, Dr. Wendy Pons, took over from Dr. Andrew Papadopoulos in January 2024. Andrew is thanked for his 13 years of successful service.
- Articles focusing on environmental public health practice are the focus of many submissions and are among the most frequently read in the journal. The journal has been receiving articles from researchers affiliated with CIPHI-accredited schools. Environmental public health professionals returning to graduate studies is another source of high-quality articles.
- Submissions from the National Collaborating Centre for Environmental Health (NCCEH) are in high demand and are amongst the most read sections of the journal. The NCCEH will start contributing articles again in issue #3 this year. They will also promote their articles by linking them to the EHR Journal through their website.
- Relevant journal summaries provided by Nelson Fok continue to be a regular and valuable component of the *Environmental Health Review*.
- Contributions from the Branch Presidents have been decreasing steadily over the past few years, Issue #2 contained 2 Branch President reports (Ontario and Saskatchewan), but it is a challenge to get reports from all branches. There appears to be limited interest in continuing this practice.
- Fees paid to Canadian Science Publishing (CSP) have increased modestly; however, it would be difficult to continue publishing without their partnership. The Canadian Institute of Public Health Inspectors (CIPHI) is granted membership within CSP, and the current representative is the Editor.
- Promotion of journal issues through social media (LinkedIn and Instagram) has brought increased views to Issue #2 of this year. This also increases visibility to potential authors, which can encourage authors to submit. There is no cost for this.
- There was a new feature published in Issue #2 of this year, titled "Spotlight: A close up of student initiatives in public health". This section aims to showcase the work undertaken by students from each of the six CIPHI-accredited schools in Canada, highlighting their innovative contributions to public health. In each issue, one school will share the work of its students. The first feature in this issue showcased Conestoga College. This initiative will hopefully strengthen the link between the CIPHI members, the EHR, and the accredited school across Canada.





Future Targets

- There have been challenges integrating the new CIPHI website with the journal website (security and sign-in issues). This issue can be considered in joint with open-access publishing. The publisher (CSP) encourages more journals to move to open access, which is the trend in scientific publishing. We will explore the impacts of officially having an open-access Journal for 2025.
- Apply to have the EHR indexed in PubMed. This will bring increased visibility to the Journal and to the work of authors publishing in the EHR.
- Continue to promote article submissions from all CIPHI-accredited institutions (faculty and students), especially through the new Spotlight feature.
- Continue to promote case study submissions from CIPHI members across Canada, as this is a great source of content that is highly relevant and interesting to our members.
- Discuss with the NEC the continuation of the Branch Presidents' Report.
- Continued promotion of the Journal through social media





National Historian's Report 2024

Mr. President, please find my report for the past year. As stated in previous reports I am continuing to look for historical information and pictures regarding both our National organization and all our branches past and present. Unfortunately, it is becoming more difficult to locate information from across Canada since the majority of branches no longer have active Branch Historians. To resolve this important and continuing shortfall I am recommending to the NEC that CIPHI implement a new policy that the Past Branch Presidents take on the roll as Branch Historian during their term as Past President. There are several advantages to this proposal. First, Past Presidents are very familiar with recent happening across their branch and second, they have very few if any duties other than to act as Branch President in the absence of the President which seldom happens other short events such as vacations or illness. This would really help collecting and sharing local historical information and over time increase the number of branch members knowledgeable in branch historical matters. I request that this proposal be supported by the National Executive and implemented in the near future. The recent passing of Stefane Gravelle in Manitoba is a very sad event for many reasons and a real blow to the Historical Committee as he was most active in collecting historical information in Manitoba where the Institute formed, and he was our only committee member who could speak and read French which was very important when dealing with historical matters in Quebec.

I have almost completed the list of all Branch Presidents across Canada from the formation of each and including the former "Atlantic Branch". With an excellent tip from Peter Rogers in Winnipeg, I was able to meet with James Scyrup the **Great-Great-Grandson** of the first President of the BC Branch, **Mr. Laurence Robertson** (1925-1928). He provided excellent information about Mr. Robertson including several photos. We now have the names and photos of all 40 Presidents of the BC Branch. The list is also complete <u>including photos</u> for all Branch Presidents in Alberta, Saskatchewan, Manitoba, Ontario, and Newfoundland back to the dates those branches were formed. The Quebec Branch is still proving to be difficult to complete due to its dissolution back in the 1980s but I'm halfway there with names and photos of the Presidents. I hope to complete the old Atlantic Branch plus the Nova Scotia/PEI, New Brunswick and Quebec branches before our AGM next year.

I believe there are about 900 key members and/or supporters of Institute since it was formed back in 1918 and I now have photos or sketches of over 800 of these key individuals. It is now time to create a Historical Section on our website and upload the photos and information which I have collected. At a minimum we should start with the photos and names of the <u>National and Branch Presidents</u> collected to date for members to view prior to the annual educational conference to be held in BC in 2025, <u>the 100th Anniversary of the BC Branch.</u>





As I have stated before I would encourage Branch Historians and interested branch members to actively seek out historical information through provincial archives, historical societies, community health agency records, and retired colleagues. Interviews with fellow retired members can uncover a wealth of information and pictures which need to be saved as well. The smallest clue may lead us to a treasure trove of historical items. Please save those items for us.

Our committee membership has shrunk a bit from last year with the apparent loss of committee members in Alberta.

Retiree Advisory Committee Report 2024

Introduction:

The Retirees Advisory Committee (RAC) was established in September 2005 as a joint project of the Canadian Institute of Public Health Inspectors (CIPHI) and the Public Health Agency of Canada to address the need for qualified public health inspectors to deal with potential public health emergencies; determine a framework to serve as a tool to enhance the public health system capacity; and serve as a pilot for the establishment of retiree committees in other public health disciplines. The experience and corporate knowledge of retired public health inspectors should be considered an asset to the future planning of public health initiatives.

Roles and Responsibilities: (from the new Terms of Reference)

To advise, promote and support retired environmental public health professionals from all regions of Canada while supporting the pillars, vision, mission, and values of CIPHI:

- Networking with retired environmental public health professionals:
 - Identify retired CPHI(C)s (both CIPHI Retired Members and non-members) and maintain a voluntary contact list that includes relevant contact information and public health skillsets.
 - Send letters of congratulations to recently retired CPHI(C)s including a CIPHI membership form highlighting the benefits and current fee for retired members for their specific CIPHI Branch.
 - Carry out voluntary surveys of retired CPHI(C)s.
- Advocate on behalf of CIPHI Retiree Members:
 - Generate and distribute an annual update for retired members utilizing the Senators Forum newsletter.
 - Recognize retired members through the Senators Forum newsletter.
 - Create networking opportunities for CIPHI Retired Members.
- Liaise with the National Executive Council (NEC) on behalf of CIPHI Retired Members:
 - Participate in committee projects as directed by the NEC.
 - Prepare an annual work plan for review and discussion with the NEC to ensure that the committee's activities align with the CIPHI pillars, vision, mission, and values.
- Recognition of deceased CPHI(C)s:
 - Generate and send letters of condolence to the family of CPHI(C)s who have passed away.
 - Prepare the In Memoriam list for the CIPHI National Annual General Meeting Report.





 Ensure that all documents, reports, publications, and any other items generated because of the activities of the RAC follow the CIPHI National Operation Policy (NOP) 14 (Logo Use NOP) and all other relevant National Operating Policies and Code of Conduct.

The RAC also produces a power point presentation to be shown during the "In Memoriam" portion of the AGM to assist with memorializing our former colleagues. It is important to note that all holders of CPHI(C) are honoured regardless of whether they were a member of CIPHI at the time of their death.
- Retiree Contact Directory: The RAC continues to maintain and update a non-CIPHI member retiree database and ask that retirees provide us with their contact information in addition to email to ensure our files are current. We receive an annual Retiree and Life membership list from the CIPHI Office to update our retiree directory, but it is a challenge to keep track of retirees who are not members of CIPHI. - Senators Forum Annual Newsletter: A 2023 year in review newsletter was released in June 2024. A new feature is for retirees to submit written updates with relevant photos on their retirement life. - **Retirees E-News:** To provide information in a timely manner of relevance to retirees such as upcoming retirement celebrations and colleagues who have passed, the RAC will issue e-newsletters using the software MailChimp. Retirees who are non-members can submit their email to <u>CiphiRetireesChair@gmail.com</u>
- Facebook Page: The RAC created a Facebook group "CIPHI Retirees" for those retirees interested in networking with retired CPHI(C)s. The aim of the page is to:
 - To connect with CPHI(C) retirees (both CIPHI retired members & non-members).
 - Connect retirees with former colleagues and classmates.
- **RAC Meetings:** Since the last CIPHI National AGM the RAC has held virtual meetings on, October 29, 2023, January 21, 2024, March 17, 2024, and June 9, 2024. The meetings continue to be in a ZOOM format.
- **RAC NEC Meetings:** Since the last CIPHI National AGM, the RAC met virtually on November 20, 2023, February 6, 2024, and April 16, 2024, with the CIPHI NEC President and President-Elect to discuss many of the initiatives that the committee would like to move forward on with the support of the NEC.
- **CIPHI Website:** The RAC Past Chair has received a tutorial to carry out updates to the committee's information page on the CIPHI website. The page is currently being updated to include *Senators Forum* newsletters, Annual Reports, Meeting Minutes, and relevant documents. - **Creation of a National Mentor Award:** The RAC proposed to the NEC the creation of a new national award to honour our former RAC member and colleague Charlie Young. In early 2024 the NEC approved the creation of this award. The RAC will now be collaborating with the NEC on establishing the criteria and eligibility for award recipients beginning in 2025.
- **Creation of a 100 Year Birthday Certificate:** The RAC proposed to the NEC the creation a certificate issued by the NEC to holders of CPHI(C) who reach their 100th Birthday. The RAC developed a draft certificate for review and approval by the NEC.
- Committee Terms of Reference (TOR): During the past year the RAC and the NEC collaborated on a review and updating of the committee's terms of reference. A copy of it may be found at <u>Our</u> <u>Committees – CIPHI Website</u>
- Creation of 60-year (Diamond) and 70-year (Platinum) CIPHI Member Awards: In addition to the 50-year CIPHI member recognition award, the RAC proposed to the NEC the creation of sixty- and seventy-year CIPHI membership awards. This initiative was approved by the NEC, and the RAC are compiling a list of current and upcoming sixty- and seventy-year memberships. As well the RAC have worked with a graphic artist to design lapel pins for sixty- and seventy-year membership for review by the NEC
- Stories of Interest: The RAC wants to highlight stories of interest to the membership by featuring notable PHIs. Our first story in 2024 was that of retired PHI, Dennis Alleyne who was the very first PHI to receive his certificate from the Canadian Institute of Public Health Inspectors in 1979, after the transfer of this function from the Canadian Public Health Association on July 1st of that year. Future Initiatives:

- **Professional Development for Retirees:** The RAC Chair would like to pursue preliminary discussions with the CoPE Chair about the implementation of a process for interested retirees to maintain or earn professional development hours. This will be an asset for retirees who volunteer or are called back into service to deal with public health surge capacity. The CIPHI January 2010 Standards of Practice document detailed a conceptual piece on retirees but was not further developed. With the approval of the NEC, the RAC would like to work with CoPE on this initiative.
- **CIPHI Outreach to Retirees:** It is estimated that there are approximately 1,000 CPHI(C) retirees. As of March 31, 2024, there are 77 CIPHI retired members and 25 Life members for a total of 102 CIPHI members who are retired. As with most professional organizations, communication with members is primarily now done electronically. There are many ways that retired CPHI(C)s can stay connected with the profession. In March of this year CIPHI National moved over to MailChimp, a new email software. If you are a current member of CIPHI, your email would have been automatically moved over. Non-members are welcomed to sign up to receive national CIPHI news by going to the www.ciphi.ca home page and clicking on the "subscribe" button on the bottom of the page. CIPHI National www.ciphi.ca also has direct links to the CIPHI Branches. As well, several of the





Branches in addition to websites also have Facebook, Twitter, and Instagram accounts that retirees can follow.

• **CIPHI Board of Certification (BOC) Exams:** The RAC continues to advocate that the BOC recruit recent retirees to assist with the work of the BOC as committee members, examiners, and to assist the Branch Exam Coordinators on the day of the exam. This is especially important during times when public health services capacity is challenged. The RAC offered to organize with the BOC webinar training for those retirees who have not received the required examiner training.

In conclusion, I want to thank all of the members of the Retirees Advisory Committee for their dedication and assistance in the work we have undertaken during this past year. Your input, advice and guidance were instrumental in achieving a number of our objectives. I also want to thank the members of the National Executive Committee for their thoughtful insight, review and feedback on the work that the RAC has been doing on behalf of CIPHI. It has been greatly appreciated.

NOTES TO THE FINANCIAL STATEMENTS December 31, 2023 (Unaudited)

1. STATUS AND PURPOSE

Canadian Institute of Public Health Inspectors (the "Institute") is incorporated without share capital as a not-for-profit organization under the Canada Not-For-Profit Corporations Act. The Institute represents and unites Environmental Public Health professionals across Canada, advances the profession and field of Environmental Public Health through certification, advocacy, education and professional competencies.

2. SIGNIFICANT ACCOUNTING POLICIES

These financial statements are prepared in accordance with Canadian accounting standards for not-forprofit organizations. The significant policies are detailed as follows:

(a) Revenue recognition

The Institute follows the deferral method of accounting for contributions. Restricted contributions are recognized as revenue in the year in which the related expenditures are incurred. Unrestricted contributions are recognized as revenue when received or receivable when the amount to be received can be reasonably estimated and collection is reasonably assured.

(b) Fund Accounting

These financial statements have segregated operations by the following fund classification:

(i) Capital Fund

The Capital Fund reports common tangible capital assets, their related financing, and amortization.

(ii) General Fund

The General Fund reports unrestricted resources used for administrative activities and general service delivery.

(iii) Council of Professional Experience Fund (CoPE)

The Council of Professional Experience Fund reports restricted resources used to support the administration of the continuing professional competencies program for all Certified Environmental Public Health Professionals.

(iv) Board of Certification Fund (BoC)

The Board of Certification Fund reports internally restricted resources used for the certification process.

(c) Contributed services

Volunteers contributed time to assist the Institute in carrying out its purposes Because of the difficulty of determining their fair value, contributed services are not recognized in the financial statements.

NOTES TO THE FINANCIAL STATEMENTS (Unaudited) December 31, 2023

2. SIGNIFICANT ACCOUNTING POLICIES, CONTINUED

(d) Tangible and intangible capital assets

Tangible and intangible capital assets are recorded at cost. The Institute provides for amortization using the following methods at rates designed to amortize the cost of the tangible and intangible capital assets over their estimated useful lives. The annual amortization rates and methods are as follows:

Computer equipment	Straight-line	3 years
CPC Database	Straight-line	20 years
Trademark	Straight-line	15 years

(e) Investments

Investments consist of term deposits which are recorded initially at fair value and adjusted annually for accrued interest receivable with revenue recognized in the fund in which the investment is held.

(f) Income taxes

For income tax purposes, the Institutes a non-profit organization exempt from income taxes under Section 149(1)(I) of the Canadian Income Tax Act.

(g) Use of estimates

The preparation of financial statements in conformity with Canadian accounting standards for not-forprofit organizations requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. By their nature, these estimates are subject to measurement uncertainty. The effect of changes in such estimates on the financial statements in future periods could be significant. Accounts specifically affected by estimates in these financial statements are depreciation on both tangible and intangible capital assets.

(h) Financial instruments

(i) Measurement of financial instruments

The Institute initially measures its financial assets and liabilities at fair value, except for certain related party transactions that are measured at the carrying amount or exchange amount, as appropriate.

The Institute subsequently measures all its financial assets and financial liabilities at cost or amortized cost, except for investments in equity instruments that are quoted in an active market, which are measured at fair value. Changes in fair value are recognized in the statement of operation and changes in net assets.

Financial assets measured at amortized cost include cash, accounts receivable, and investments.

Financial liabilities measured at amortized include accounts payable and rebates payable.

(h) Financial instruments, CONTINUED

(ii) Impairment

Financial assets measured at cost are tested for impairment when there are indicators of impairment. The amount of the write-down is recognized in the statement of operation and changes in net assets. The previously recognized impairment loss may be reversed to the extent of the improvement, directly or by adjusting the allowance account, provided it is no greater than the amount that would have been reported at the date of the reversal had the impairment not been recognized previously. The amount of the reversal is recognized in the statement of operation and changes in net assets.

(i) Related parties

Related party transactions are in the normal course of operations and have been measured at the exchange amount which is the amount of consideration established and agreed to by the related parties.

3. INVESTMENTS

Investments consist of term deposits held with Vancity Credit Union. Term deposits with maturity dates less than 90 days from the year end are classified as long-term assets when management intends to renew the investment at maturity.

5. DEFERRED CONTRIBUTIONS RELATING TO INTANGIBLE CAPITAL ASSETS

Deferred contributions relating to intangible capital assets represent restricted 'CIPHI Continuing Professional Competencies (CPC) Project' contributions with which the Environmental Public Health database system was developed. The contributions are being amortized to revenue in accordance with the depreciation of the database system.

6. DEFERRED REVENUE

Deferred revenue consists of BoC exam fees, membership dues and miscellaneous fees received in the current year that are for the subsequent year.

7. FINANCIAL INSTRUMENTS

The Institute's financial instruments consist of cash, investments, accounts receivable, and accounts payable and accruals. Unless otherwise noted, it is management's opinion that the Institute is not exposed to significant interest, currency, or credit risks arising from these financial instruments.
